Only one (1) Recreational Vehicle is permitted to be occupied on a lot with an existing dwelling unit. **A permit is not required for occupations less than ten (10) consecutive days.**
- **RV Occupied for more than ten (10) days but less than six (6) months:** RV's may only be occupied on a temporary basis and may not be used as a primary dwelling, domicile, residence or business. Only one (1) Recreational Vehicle is permitted to be occupied on a lot with an existing dwelling unit. **A permit is required for occupations more than ten (10) consecutive days but cannot exceed more than six (6) months in a calendar year.** Such occupied Recreational Vehicles must have a domestic water supply and adequate provisions for wastewater disposal including sewerage, septage and gray water. Such Recreational Vehicles shall not be rented for commercial gain.
